Introduction

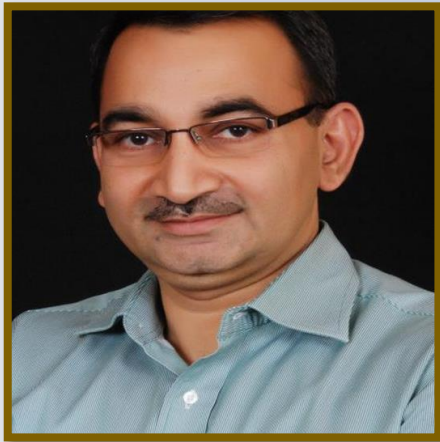

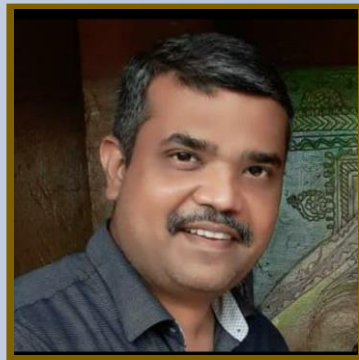

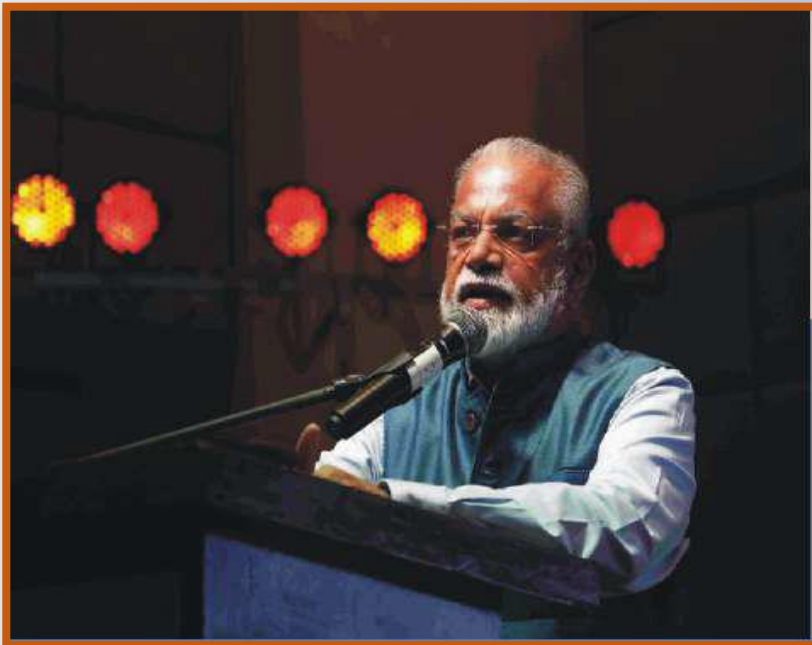

Dr. Manu Prakash

(BT/CSE/2002) was conferred with the Young Alumnus Award 2019 in recognition of his stellar contributions to his innovative research into using technology for betterment of people's health all over the globe.

Alumni in focus

Dr. Arvind Krishna (BT/EE/1985) has been appointed as the CEO of IBM. He previously served as the Senior Vice-President, Cloud and Cognitive Software at IBM.

Dr. Krishna began his career at IBM in 1990, at IBM's Thomas J. Watson Research Center, and was promoted to Senior Vice President in 2015, managing IBM Cloud & Cognitive Software and IBM Research divisions. He was a principal architect of the acquisition of Red Hat, the largest acquisition in the Company's history.



Dr. Pawan K Goenka (BT/ME/1975) is an Indian businessman, and the Managing Director of Mahindra and Mahindra Limited, an Indian multinational automobile manufacturing corporation headquartered in Mumbai, and the chairman of SsangYong Motor Company in Korea. He attended a six-week Advanced Management Program at Harvard Business School. He worked at General Motors R&D Centre in Detroit, U.S., from 1979 to 1993. Thereafter he joined Mahindra & Mahindra Ltd., as general manager (R&D). He was the chairman of board of governors of IIT Madras. Dr. Goenka has been elected as an International Member to the prestigious USA National Academy of Engineering.





Dr. Ajay Bhushan Pandey (BT/EE/1983) is a 1984 batch Indian Administrative Service (IAS) officer belonging to the Maharashtra cadre. He was appointed the new finance secretary of India. He successfully led the Department of Revenue, and GST Network. Dr. Bhushan was former chief executive officer (CEO) of the Unique Identification Authority of India (UIDAI), the nodal agency of Government of India responsible for implementing Aadhaar.



Dr. Abdul Qayum (BT/CE/2008) works for the Ministry of Environment, Forest & Climate Change, Govt. of India. He is currently posted as Deputy Conservator of Forests DCF Chandigarh with additional responsibility of Science & Technology & Solar CREST, UT Administration, Chandigarh. Dr. Qayum has a burning desire to protect people dependent on the forests for their survival (vulnerable tribal communities), who are equal partners in the quest for conservation. He was felicitated with National Award for eGovernance 2020. It was for the recognition of the work he did in Arunachal Pradesh to reduce the number of forest fire cases.

Over more than 30 years, he has held key positions within UOP, spanning research and development, engineering, and marketing, including vice president and chief technology officer of UOP. He has been elected as a member of the prestigious USA, National Academy of Engineering.

Dr. Sandip Patil (PhD/CHE/2013) is an entrepreneur, technologist, founder and managing director of an enterprise E-Spin Nanotech Pvt. Ltd. at SIDBI, IIT Kanpur. He founded the company E-Spin Nanotech Pvt. Ltd. in 2010, and this startup was involved in developing world class nanofiber spinning machine. He has several patented technologies used in mass scale production of nanofibers/nanoparticles for R&D purpose. His company achieved numerous breakthroughs in developing highly advanced electrospinning machine, designing N-95 facemasks (SWASA-N95) & capturing a large market of stakeholders. He was among top 3 finalists for "TIME India start-up Innovator" of the year award 2017 and got awarded among "Top 10 young outstanding business person 2016" in Kanpur. He received Rajeev Motwani Young Entrepreneur award by Motwani foundation 2014, he was also felicitated with IChE Shah-Schulman Award for best PhD Thesis in the area of Colloid & Interface Sciences in 2013. He was recently awarded the Bangalore Nano Innovation Award for the high impact Nanotechnology Innovation and commercialization.

Dr. Jha has been invited to join the editorial board of the IEEE Sensors Journal, USA. The IEEE SJ, USA is a peer-reviewed, semimonthly, premier journal devoted to sensors and sensing phenomena.

Prof. Mohit Bansal (BT/CSE/2004) is the John R. & Louise S. Parker Associate Professor (tenured) and the Director of the MURGe-Lab (UNC-NLP Group) in the Computer Science department at University of North Carolina (UNC) Chapel Hill. Prior to this, he was a research assistant professor (3-year endowed position) at TTI-Chicago. His research expertise is in statistical natural language processing and machine learning, with a particular focus on multimodal, grounded, and embodied semantics.

Prof. Bansal was awarded the prestigious Director's Fellowship by The Defense Advanced Research Projects Agency (DARPA), University of North Carolina.

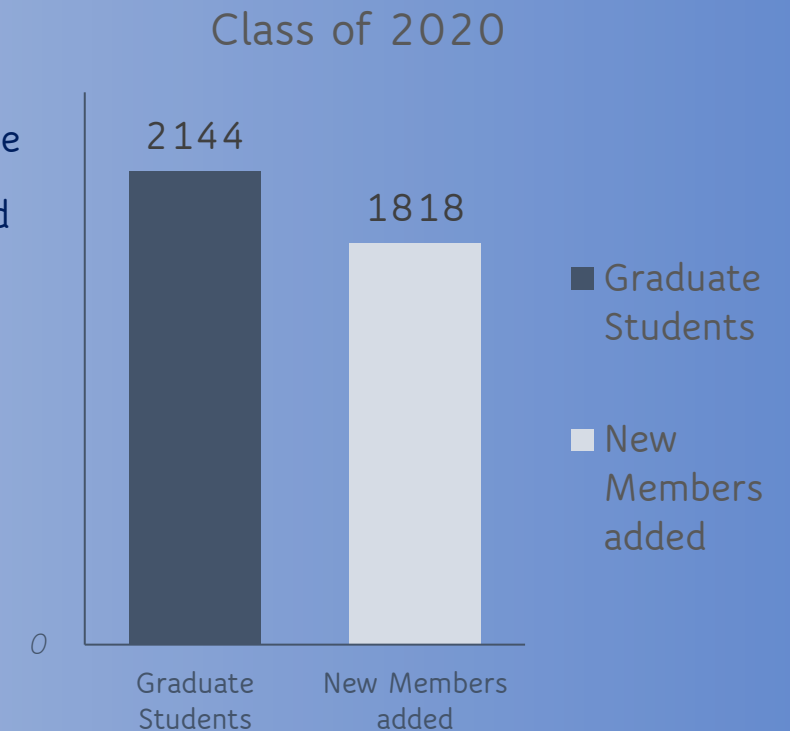


Alumni Association, IIT Kanpur has created a drive to expand the alumni database by adding more than 1818 new members into its database

- ✓ Many of our senior alums participated and contributed.
- ✓ Alum Association signed the MoU with MEITY & NITI Aayog for partnering and mentoring.

PAN IIT - India

PAN IIT activities have been around organization of conclave and Hackathon 2020.

Alumni Association was the part of the organizing team and was able to pull in 17 out of 21 Directors in the Directors' workshop. The theme covered the issues in the new IITs, Sustaining IIT operations and becoming global leaders.
