Minutes of the 7th Board of Directors Meeting

1. Welcome Address

The Alumni Association (AA) President, Mr. Rakesh Sharma, and Secretary, Prof. Arun K. Saha, welcomed all members present.

2. Ratification for Alumni Spouse to be Treated as an Alum if the Alumni Passes Away

The board unanimously agreed that the spouse of an alum will be treated as an associate member if the alum passes away. The spouse and children under the age of 25 will be covered under the alumni insurance policy, regardless of whether the alumn had previously enrolled in the policy.

Resolution: This amendment will be incorporated into the Alumni Association's constitution.

3. Discussion on RBI Bond Fund of Rs. 2 Crores from SBI

The board discussed the RBI Bond held by the Alumni Association.

Resolution: The President and Secretary will initiate talks with SBI to manage the RBI Bond fund.

4. Proposal to Fund the IITK Alumni Office and Satellite Office in Bangalore

The Director of IIT Kanpur proposed funding the IITK alumni office and satellite office in Bangalore. The Director has agreed to provide a space adjacent to the DoRA office for the Alumni Association office.

Resolution: The Director will formalize the provision of office space and financial support.

5. Appointment of Mr. Amod Agrawal and Dr. Chandan Upadhyay as Negotiators for Alumni Health Insurance

The board approved the appointment of Amod Agrawal and Chandan Upadhyay as negotiators for the Alumni Health Insurance policy for the upcoming year. Additionally, three members from the special consultancy group of 50 members will be co-opted into the insurance committee.

Resolution:: Mr. Amod Agrawal and Mr. Chandan Upadhyay will lead the negotiations, with additional members being co-opted into the committee.
