Minutes

Agenda 1: IITK-AAIITK relationship discussion (MOU, Secretary & Treasurer non-IITK employee)

The president AAIITK, Mr Shyamendra Narain, & Secretary Prof. Jayant K. Singh welcomed the board members as well as the new Office Manager. Secretary informed the board that IITK is working on MOU regarding the relationship between IIT & AAIITK, which will be presented in the next meeting.

Secretary further informed that Institute has received numerous emails questioning secretary and treasurer to control AA, and thus interfering the business of AA. Thus, the Institute has decided that secretary and treasurer of the Alumni association should not be under the payroll of IIT Kanpur. Rather, they should be Alumni (by-election or appointment by the board) in order to safeguard the legal conflicts.
