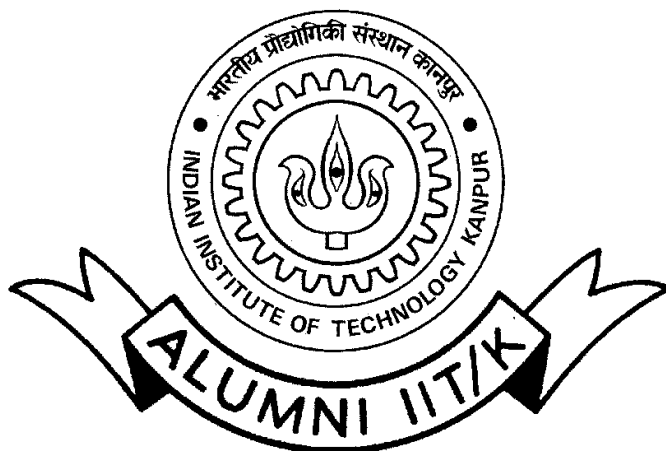

3.1 Composition of the Board

The members present expressed concern over the vacant positions in the Board of Directors (2016-18).

3.1.1 For the positions of the Secretary and Treasurer, who come from within the Institute, it was felt that various operational activities and functions of the Alumni Association office should go on uninterrupted. It was unanimously decided that the Secretary and Treasurer should continue till the new arrangements are made. Further, given that the Institute will have summer vacations till the end of July and there are several important activities already planned, after discussions, it was decided that both Secretary and Treasurer should be requested to continue till December 31 2016.
