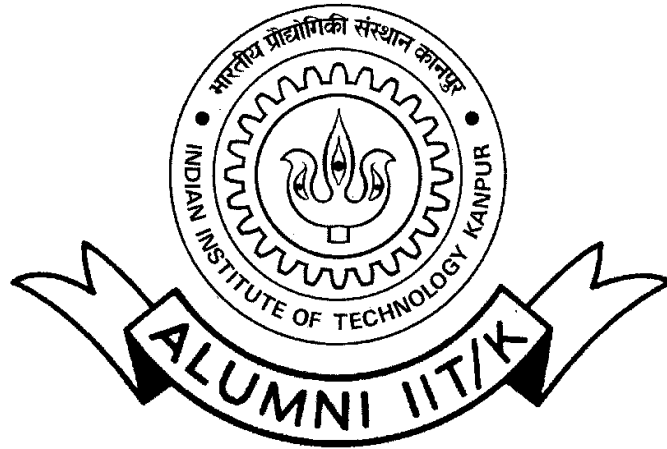

4.7.1 Alumni – Facebook Account

- (2) In case a favorable response is not obtained to then the matter should be brought to the Face Book organization with a request to examine the issue and
- (3) A policy be framed for future operation of the account so that such kind of afore mentioned unpleasant situation does not arise.

If the need be the matter could also be brought to the attention of the patron and seek his guidance and help in the matter.
